# **Position Objectives:**

Archaeology Southwest seeks an individual with proven success in building meaningful and powerful collaborative relationships with Native American Tribes and Nations. The individual should have knowledge of Tribal governance and be able to develop action-oriented programs by, for, and with Indigenous peoples.

A core element of Archaeology Southwest's Tribal Collaboration Initiative is the joint Archaeology Southwest—Bureau of Indian Affairs (BIA), Western Region Office, effort to implement and enforce the U.S. Archaeological Resources Protection Act (ARPA). This multi-year initiative is being implemented through the Desert Southwest Cooperative Ecosystem Studies Units (DS-CESU). The selected applicant will lead a team that conducts and supports archaeological resource damage assessments, produces damage assessment reports, facilitates ARPA training sessions, and engages with public audiences to prevent looting and increase reports of violations. The selected candidate will also provide guidance to the CEO and to program directors on enhancing and expanding engagements with Tribes across all Archaeology Southwest projects and activities.

The selected candidate will work closely with archaeologists, Tribal and Federal government agencies, law enforcement, and legal specialists to advance the goals of the BIA and Archaeology Southwest. Applicants should have the personal and professional skills and desires to establish positive and effective working relationships among team members with diverse backgrounds and interests. We especially encourage applications from candidates who identify as Native American.

## Responsibilities:

- Play a leadership role in guiding Archaeology Southwest's Tribal Collaboration Initiative
- Manage multiple concurrent projects within the BIA partnership
- Supervise office and field personnel
- Act as project director on archaeological damage assessments, archaeological site monitoring, and site repair and remediation treatments throughout the western United States
- Author or co-author damage assessments and technical reports
- Implement and refine recommended practices for investigating and documenting ARPA violations
- Organize and participate in formal and informal trainings to create and refine the knowledge, skills, and abilities required by archaeologists, law enforcement specialists, and others to contribute to archaeological damage assessments meeting the highest standards
- Identify, plan, support, and carry out Tribal, public, and professional engagement initiatives
- Produce content and provide quality assurance for SaveHistory.org, including blog posts and video storytelling
- Create annual and project-specific budgets, scopes of work, and associated rationales
- Perform or provide quality assurance for all program administrative and operational duties, as necessary and appropriate

- Bachelor's degree in anthropology, archaeology, criminology, Indigenous studies, environmental studies, or other relevant discipline
- Five or more years of experience in archaeological fieldwork, law enforcement, environmental stewardship, land management, or other relevant discipline
- Successful project, program, or team management across at least three years of prior work experience
- Available to respond to requests for work assignments outside of Tucson with little advance notice
- Ability to conduct field work for long hours in challenging conditions—remote locations, rugged terrain, uncomfortable weather—and carry up to 25lbs of equipment
- Strong technical writing and communication skills, including demonstrated expertise in the preparation of reports on the results of data or evidence collection and analysis
- Adhere to standards on the handling of forensic evidence and confidential information
- Highly organized, detail-oriented, and able to meet deadlines
- Valid driver's license and good driving record

- Master's degree in anthropology, archaeology, criminology, Indigenous studies, environmental studies, or other relevant discipline
- Technical skills in archaeology or environmental stewardship, including drawing maps, photography,
   GPS, artifact identification, and knowledge of the U.S. Southwest's Indigenous history and culture
- Experience with Trimble hand-held GPS units and Terrasync software
- Registered Professional Archaeologist (RPA), Registered Professional Forester, Commissioned law enforcement officer, or equivalent
